## ACORD P&C and Life/Annuity/Health Form Changes and Additions

The following pages include both a List of new and recently revised ACORD forms and an Explanation of the Changes made.

Beginning in 2013, we made an enhancement to our filing and forms release processes. Whenever possible, new and revised ACORD forms will be made available one to six months in advance of the form effective date. In these instances, companies will have this additional time to implement the forms into their systems before the current versions are replaced. Both the current versions and the revised future effective date versions will be found on the Forms Download page at <a href="www.acord.org">www.acord.org</a>. The effective date included on the footer of all forms will match the date the form must be used in all jurisdictions in order to ensure compliance with our filings.

Also on the ACORD website on the Forms Download page, there is a menu item listed on the left entitled, **Related Forms**. This link will open an excel file which lists Parent forms and their children (the forms that may or should be attached to the Parent form). This file will be updated any time new ACORD forms are added to the current library.

Copies of the forms referenced in this announcement can be downloaded in the formats you need at <a href="www.acord.org">www.acord.org</a>. To download forms, you will need to "sign-in" as an ACORD member with your user name and password. Once you are signed in, click on the Forms button, and then click on Download Forms to access the ones you need. #### **Umbrella/Excess Section**

- 1. Page 2, adds UNDERLYING GENERAL LIABILITY INFORMATION section, sub-section 1, added the following new language, "(In Oklahoma, the underlying General Liability coverage cannot contain defense costs within the limits: subject to Commissioner's Orders.)"
- 2. Page 5, Fraud Statements section, increased the font to 10 pt.
- 3. Page 6, (new page 6 due to increase in font sizes in Fraud Statements and Signature Sections), Signature Section, increased the font to 10 pt.
- 4. Revise copyright dates to 2017.

#### 61 DE (2017/12)

#### **Delaware Auto Supplement**

- 1. Changes the minimum of automobile insurance to \$25,000, (per person) \$50,000 (per accident) and \$10,000 (property damage) for the minimum of liability coverage.
- 2. Changes are consistent with 603 Delaware Motorist Protection Act
- 3. Revise copyright dates to 2017.

- 1. Changes the first page policy number to application number
- 2. Deletes box on the top right of first page
- 3. Deletes selection to check if applying for immediate coverage via fax
- 4. Deletes that the application must be faxed
- 5. Adds insured e-mail address for insured
- 6. Removes Policy Number box on second page
- 7. Removes cells relative to annual tentative premium, installment box and down payment box, replacing it with reason for application
- 8. General Information on section 9 has been completely revised
- 9. Revise copyright dates to 2017

Massachusetts Property Insurance Underwriting Association, Inspection Notice, Credit Reporting Notice and Instructions for Completing Homeowners Application

- 1. Adds language to complete via the online web application accessible through the producer portal
- 2. Adds language application via web or fax
- 3. Adds language via web, producers must login to their producer portal to access and complete the online web application
- 4. Adds a privacy notification statement on second page
- 5. Revise copyright dates to 2017

Massachusetts Property Insurance Underwriting Association, Application for Dwelling Fire and Liability Insurance Inspection and Placement

- 1. Changes the first page policy number to application number
- 2. Deletes box on the top right of first page
- 3. Deletes that the application must be typed
- 4. Adds insured e-mail address for insured
- 5. Removes cells relative to annual tentative premium, installment box and down payment box, replacing it with reason for application
- 6. Removes Policy Number box on second page
- 7. General Information on section 9 has been completely revised
- 8. Revise copyright dates to 2017

#### Florida Automobile Insurance Identification Card

- 1. Changes title to the card
- 2. Adds Selection for Rental Car Coverage on back of card
- 3. Adds Selection for Fleet Coverage
- 4. Adds VIN Number on front of card
- 5. Revise copyright dates to 2017
