# ACORD P&C and Life/Annuity/Health Form Changes and Additions

The following pages include both a list of new and recently revised ACORD forms and an Explanation of the Changes made.

Beginning in 2013, we made an enhancement to our filing and forms release processes. Whenever possible, new and revised ACORD forms will be made available one to six months in advance of the form effective date. In these instances, companies will have this additional time to implement the forms into their systems before the current versions are replaced. Both the current versions and the revised future effective date versions will be found on the Forms Download page at <a href="www.acord.org">www.acord.org</a>. The effective date included on the footer of all forms will match the date the form must be used in all jurisdictions in order to ensure compliance with our filings.

Also on the ACORD website on the Forms Download page, there is a menu item listed on the left entitled, **Related Forms**. This file lists Parent forms and their children (the forms that may or should be attached to the Parent form). This file will be updated any time new ACORD forms are added to the current library.

To download forms, you will need to "sign-in" as an ACORD member with your user name and password. Once you are signed in, click on the Forms button, and then click on Download Forms to access the ones you need. 2. Various changes in the text of the form as per the Regulation, with addition on page 1: "Unless you have purchased the appropriate endorsement, your policy excludes coverage for livery conveyance. If you are a driver for a transportation network company please verify you have purchased appropriate coverage."

COLORADO PRIVATE PASSENGER AUTOMOBILE INSURANCE SUMMARY DISCLOSURE

- 3. Page 2 of 4, adds: "Unless you have purchased the appropriate endorsement, coverage", under B. Physical Damage Coverage.
- 4. Page 4 of 4, additions and changes to section C. Increase in premium. After the words the following reasons, delete the ":" and add "." and the language "Some examples of reasons for increased premium include, but not limited to:"
- 5. Page 4 of 4, delete after surcharge or remove the following: "an accident free" and add "a" after *remove*. To the last sentence of page 4, after *you will receive* delete the rest of the sentence and add "a notice of your statutory right to file a complaint with the Colorado Division of Insurance."
- 6. Revises copyright dates to 2018 and date of form.

### 1. 50FL (2017/12) FLORIDA AUTOMOBILE INSURANCE CARD

FIG was updated for clarity on the definition of automobile.

## 2. 329 (2014/12) AVIATION PRODUCTS LIABILITY

On page 1 of the Form, under the Section "Coverage", changes were made to the eLabels and FIG was changed to reflect the improvements made to the eLabeling.

# 3. 65 MA (2017/11) MASSCHUSETTS PROPERTY INSURANCE UNDERWRITING ASSOCIATION

Application for Dwelling Fire and Liability Insurance Inspection and Placement

Non-compressed XFDL format added in place of a compressed format.

These are not new form editions. The static text of the forms have not changed.
