- 1. ACORD 50 TX (2020/01)
  TEXAS LIABILITY INSURANCE CARD
- 1. Deleted the following:

Warning: A NAMED DRIVER POLICY DOES NOT PROVIDE COVERAGE FOR INDIVIDUALS

RESIDING IN THE INSURED'S HOUSEHOLD THAT ARE NOT NAMED ON THE POLICY.

2. New Edition date added to the card.

For reference, Section 601.081(b) of the Texas Transportation Code, was amended to delete a disclosure requirement. The disclosure, no longer required, was as follows:

Warning: A NAMED DRIVER POLICY DOES NOT PROVIDE COVERAGE FOR INDIVIDUALS RESIDING IN THE INSURED'S HOUSEHOLD THAT ARE NOT NAMED ON THE POLICY.

This disclosure was deleted.

Additionally, for reference, Texas Insurance Code § 1952.353 was modified to prohibit an insurer writing automobile insurance in Texas from delivering, issuing for delivery, or renewing a named driver policy unless the named driver policy is an operator's policy. An insurer may use a named driver exclusion only if the exclusion specifically names each excluded driver and does not exclude a class of drivers and the named insured accepts the exclusion in writing. Please consult the applicable sections for more information.

The change in law applies only to an insurance policy that is delivered, issued for delivery, or renewed on or after January 1, 2020.

While ACORD 50 TX does not require approval or filing, it was submitted to Texas Department of Insurance and ACORD was advised that it did appear to meet the Texas Administrative Code requirement.

## 2. ACORD 61 SC (2019/09) SOUTH CAROLINA AUTO SUPPLEMENT, OFFER OF OPTIONAL UM/UIM COVERAGE

- 1. Changed Agency to Producer.
- 2. Deleted 550 in the second paragraph and insert 600.
- 3. Further, the Edition Date and Copyright changed and ACORD logo has changed.

The amount for the fee to drive uninsured has increased, effective 9-1-2019 from \$550 to \$600. For reference, Section 56-10-510 of the South Carolina Code of Laws requires every person registering an uninsured motor vehicle to pay a fee. The Department of Insurance determines the fee, and pursuant to Order No. 2019-03, the fee has increased to \$600.

The form has been filed and approved with the Department of Insurance.
