 ARIZONA AUTO SUPPLEMENT UNINSURED/UNDERINSURED MOTORISTS COVERAGE SELECTION FORM
 - 1. New ACORD logo on top of the page.
 - 2. Change Form edition.
 - 3. Change amounts of Uninsured and Underinsured Motorist Coverage from \$30,000 to \$50,000 and \$15,000/\$30,000 to \$25,000/\$50,000.
 - 4. Change copyright and form edition.

This change was made in response to 2019 Arizona Senate Bill No. 1087 which in parts provides that for a policy that is issued or renewed beginning on July 1, 2020, except for a policy that is

issued to a person that has a valid certificate of self-insurance or partial self-insurance pursuant to section 28-4007, the minimum motor vehicle liability policy requirements are as follows:

- (i) \$25,000 because of bodily injury to or death of one person in any one accident.
- (ii) Subject to the limit for one person, \$50,000 because of bodily injury to or death of two or more persons in any one accident.
- (iii) \$15,000 because of injury to or destruction of property of others in any one accident.
