  Virginia Auto Supplement Rental Reimbursement Coverage
  - 1. New ACORD logo on the form.
  - 2. Field for Date added to form on top right.
  - 3. Struck out COMPREHENSIVE and added "OTHER THAN COLLISION".
  - 4. The Edition Date and Copyright has been changed.

This a regulatory change, consistent with Section 38.2-2230 of the Code of Virginia which requires that every insurer issuing a new or renewal policy of motor vehicle insurance, as defined in § 38.2-2212 of the Code of Virginia, which provides collision or other than collision coverage, must offer, in writing, to the named insured the option of purchasing rental reimbursement coverage.

The form was changed as per the Virginia State Corporation Commission Bureau of Insurance.

### 2. ACORD 137 VA (2019/05) Virginia Commercial Auto

- 1. New ACORD logo was added to this form.
- 2. Page 2 of 3: Covered auto symbols 44 and 46 were struck and symbols 42 and 47 were added.
- 3. Further, the Edition Date and Copyright changed and ACORD logo has changed. This was for compliance with VA Code Ann. §38.2-2201.
