1. ACORD 68 (2019/06)
Electronic Delivery Supplement – Electronic Selection/Rejection Option Form

This form may be used to obtain consent from insureds prior to engaging in any electronic delivery of insurance policies and/or supporting documents in connection with the policy. The insured has the right to select electronic delivery, select electronic delivery and paper delivery, reject electronic delivery or withdraw a prior consent if the insured no longer wants to receive electronic delivery of the insurance policy and/or supporting documents in connection with the insurance policy. This form has been filed and approved in Illinois.

The form shall not be construed to modify, limit, or supersede the provisions of the Federal Electronic Signatures in Global and National Commerce Act, as amended.
