



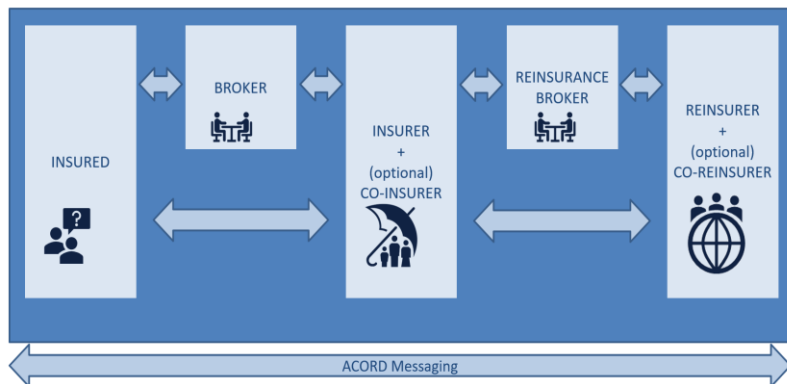

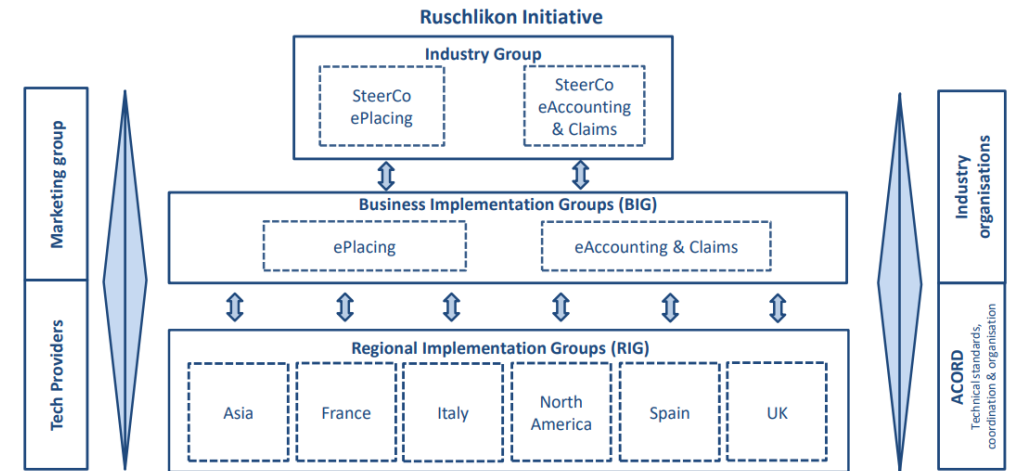

How the initiative is organised:



The Ruschlikon organization with its various bodies currently consists of 40 companies. Their representatives meet regularly to drive the initiative forward.

Steering Committees ePlacing / eAccounting & Claims

- Determine objectives, strategy and priorities
- Work in close collaboration with all stakeholders
- Globally coordinate activities with other representative groups such as industry associations, vendors, etc.



Business Implementation Group ePlacing:

- Standardize the generic data attributes used in the various phases of placing using existing (or where necessary enhanced) standards
- Agree and formalize process flows & protocols for placing in line with business needs
- Build best practice and implementation guides, share success factors and potential challenges
- Enhance the test harness infrastructure by including ePlacing tests to support smooth deployments



Business Implementation Group eAccounting & Claims:

- Evaluates/refines enhancements - to be submitted to the ACORD standard process for approval by all relevant ACORD members
- Maintains the Global (Re)insurance Best Practice, Implementation and Reference guides
- Coordinates changes across the entire Ruschlikon community to support uniform adoption of the Ruschlikon Best Practice and ACORD data standards

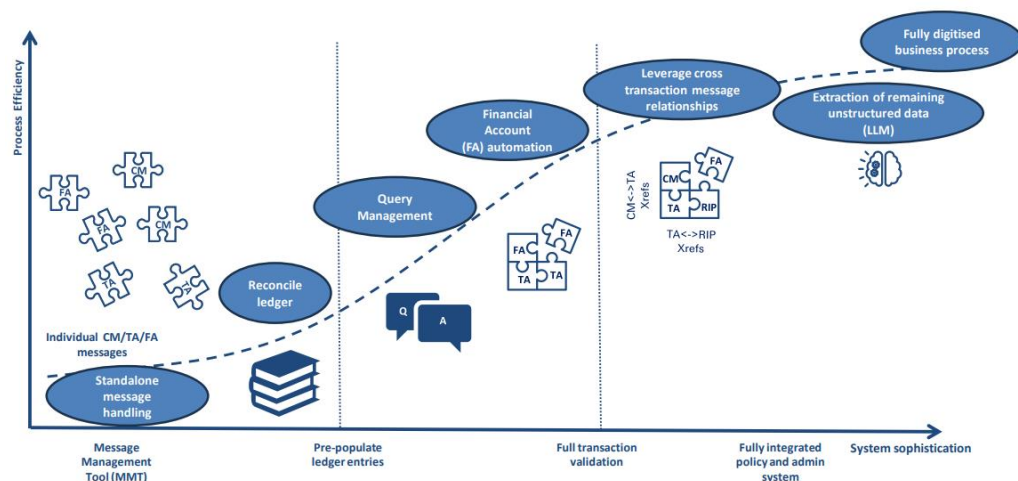
Regional Implementation Groups:
