203 / 1203 Holding Inquiry & Transmittal

Function

- The 203 Holding Inquiry is used to request detailed holding information about any kind of Holding (Policy, Investment, Banking, etc.). The data points vary based on Holding Type, InquiryLevel, InquiryView, and implementation needs. The 115 Policy Administration Inquiry is more widely used for non-financial inforce policy data. The 212 Values Inquiry is more widely used for financial inforce policy data.
- The **1203 Holding Transmittal** is used to "push" holding information such as that used for policy downloads, notifications or any other purpose. It provides information on ANY type of Holding (Policy, Investment, Banking, etc.). The data points will vary based on the Holding Type and implementation needs.
 - o Recently identified for providing notifications to agents/agencies.

Related Messages

- 502 Holding Change: used to correct data that was entered erroneously or to make miscellaneous changes. It provides a generalized method of changing data between systems, typically within an insurer carrier system(s).
- 505 Holding Status Change: used to update Policy status information.
- 115 Policy Administration: used to request information about an inforce POLICY such as its status, active riders, coverages and/or other benefits, and the parties related to the contract.
- 1115 Policy Administration Transmittal: used to "push" specific information about an inforce POLICY such as its status, active riders, coverages and/or other benefits, and the parties related to the contract.
- 1125 Case Status Notification: used to communicate status and requirements for new business and pending lapses.
