Spain

Ruschlikon is a global industry initiative, with Regional Implementation Groups for different markets. The Ruschlikon Implementation Group Spain (RIGS) has made significant progress on implementations since it was established in 2019, led by MAPFRE RE, with Swiss Re in the co-lead.

Let's highlight the key milestones of the Ruschlikon Journey in Spain:

- Contributing to the development and sign off for 23 Ruschlikon reinsurance administration templates that are now available to the global community in Spanish, English, French, German and Italian. These templates help industry partners to standardize their (re)insurance data sets, processes, and systems
- Aon Re Iberia successfully implemented B2B with MAPFRE RE and Swiss Re. Various other reinsurers will be onboarded in 2024
- MAPFRE RE onboarding with various entities from global brokers (as receiving company)
- MAPFRE RE (as sending company) and various global reinsurers (as receiving companies) making best use of technical solutions to extract data and convert them to messages thanks to the Ruschlikon standardized output documents
- Nacional de Reaseguros closely working with industry partners to consume first eMessages
- Promoting the initiative by participating in different types of events such as Spanish Insurance Week and the ENTRE

The successes of the various Ruschlikon Groups were acknowledged during the Ruschlikon 15 years Anniversary celebrations, held in summer this year, underlining again the hard work on driving digital change and transformation across our global industry. The Ruschlikon initiative - powered by ACORD – has been championing standardisation, digitisation, automation, and straight-through-processing in (re)insurance since its foundation in 2008. No other industry body has applied ACORD's data standards as holistically as Ruschlikon.
